



## **FMMA ANNUAL CONFERENCE EVENT POLICIES**

By registering to attend the Free Market Medical Association (FMMA) conference, you consent to the following policies which apply to all exhibitors, speakers, vendors, sponsors, volunteers, and attendees.

### **CODE OF CONDUCT**

Unacceptable behavior will not be tolerated at any time and may result in immediate removal from the event including:

- Offensive or unwanted behavior or language.
- Visual harassment, such as displaying sexual or offensive images OR inappropriate language.
- Intimidation or bullying, either online or in-person.
- Possession of a weapon or something that could be construed as a weapon during the event or on video.
- Photographing, video- or audio-recording of slides or oral presentations, as well as posting presentations without the presenter/author's permission.
- Sharing your event registration information, including your conference badge, with another person(s).
- Inappropriate disruption of sessions, discussions, or other events.
- Real or implied threat of physical, professional, or financial damage or harm.
- Solicitation cannot take place in the aisles or any other space in the event venue not leased to exhibitors. Soliciting is also prohibited in the mobile app or the web format (chat function in sessions, networking rooms, and activities). Exhibitors or attendees violating these rules will be removed from the event.
- Any other illegal activity not already covered above.

### **AGE RESTRICTION**

For safety reasons, anyone under the age of 18 is not allowed to register or attend a FMMA conference. Only registrants are allowed to be present in the Expo, conference sessions and receptions.

### **CONSENT FOR FMMA PHOTOGRAPHERS AND VIDEOGRAPHERS**

By attending the event, you acknowledge that your image may be captured on video or in photos taken on behalf of the FMMA. You further provide FMMA the right to use candid group photos or videos without securing additional permission, provided those images are not accompanied by further personally identifying information. Please note:

Photos and/or recordings cannot be copied, altered, sold, exhibited, or further distributed without the FMMA's prior written consent. Photos and/or recordings are the exclusive property of the Free Market Medical Association.

FMMA may post photos and/or recordings on Free Market Medical Association's official social media pages during and after the conference. You may be asked to participate in interviews, such as testimonial videos, etc. If doing so, FMMA will provide an additional consent form.

### **PERSONAL PHOTOGRAPHY AND SOCIAL MEDIA**

FMMA encourages our attendees, speakers, exhibitors, sponsors, volunteers, and vendors to share their experience at FMMA conferences on social media, unless a speaker specifically prohibits sharing of their content. ### **INFORMATION SHARING/PRIVACY POLICY**

The Conference attendee list, which contains the name and contact information of Conference registrants, may be shared with select sponsors for marketing purposes. They are not to spam attendees and have agreed to follow email communication protocol.

For the security and safety of attendees, sponsors, exhibitors, vendors, and guests, **conference badges must be worn at all times**. Each badge needs to be picked up by the individual attendee and cannot be picked up by a representative from your organization.
